- Policy Tracker: showing gap between Government net zero commitments and policies

Key Priorities:

- What sort of green recovery? The Treasury needs to be fully supportive
- Encouraging that there is genuine Government commitment to net zero and biodiversity, but more Government departments need to be on board and coordinate
- G7 and COP26 and crucial opportunities for the UK
- Decade of action is needed, not just this year
