The All-Party Parliamentary Group for the Environment is one of the **largest and most active** cross-party groups in parliament. It works across political parties to strengthen the influence of parliamentarians on public policy and debate on the environment, as well as to improve parliamentarians' access to specialist knowledge on areas like **climate and energy, waste and resources**, and the **natural environment**.

The current Chair of the APPG is **Trudy Harrison MP**, a former environment minister who also served in the Department for Transport. She represents the Lake District constituency of Copeland.



The APPG has an active committee of **cross-party Vice Chairs**, as well as over **150** parliamentary supporters.

The APPG is supported by a growing network of **associate members**, made up of businesses and charities striving to support environmental leadership.



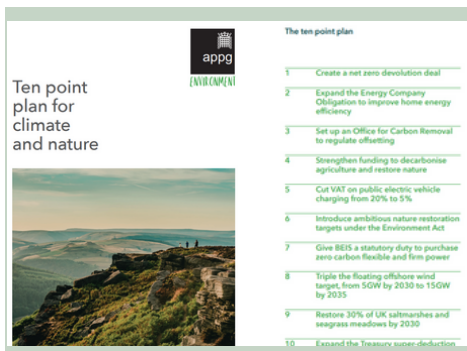

What do we do?



Throughout the year we run an active programme of **events and publications** with high profile speakers and partners. In the 2022/23 parliamentary year, the APPG produced 20 briefings for parliamentary debates, ran several in person and online events, and continued to **raise the profile of environmental issues** in parliament. For example:



Our [ten point plan for climate and nature](#) is backed by cross-party politicians, as well as businesses and NGOs, and was launched in Westminster by the chair of Natural England.



Our 2023 annual reception and awards evening featured speeches from environment minister Rebecca Pow MP and shadow climate change minister Kerry McCarthy MP.



We run site visits around the UK, such as to renewable energy projects in Bedfordshire and to visit bison in Thornden Woods, Kent.



We host regular events spanning a wide range of issues, covering topics such as the Energy Bill, Deep Sea Mining, the People's Plan for Nature and more.

Our impact



The Environment APPG has had numerous successes in raising the profile of the environment in parliament and **advancing climate and nature friendly policies**. As the oldest established all party group for environmental issues, the Environment APPG has consistently influenced public policy and provided a forum for fruitful debate, strengthening environmental leadership in the UK.

Successfully campaigned in Parliament and beyond for the UK to withdraw from the Energy Charter Treaty.

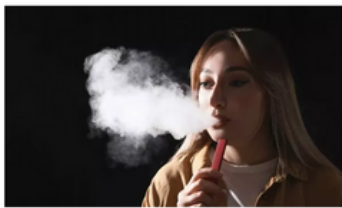
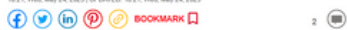


MPs call to ban disposable vapes to prevent a 'new public health catastrophe'
