#### The work of the Environment APPG:

The All-Party Parliamentary Group on the Environment works across political parties to strengthen the influence of parliamentarians on public policy and debate on the environment, as well as to improve parliamentarians' access to specialist knowledge on areas like climate and energy, waste and resources, and the natural environment.

The year saw a number of successes for the APPG. Following a letter from APPG members to the Prime Minister, the UK Government backed a moratorium on deep sea mining until the environmental impacts are better known. The Government also committed to banning disposable vapes, which are both a significant source of pollution and an irresponsible use of critical minerals. APPG member Selaine Saxby was also successful in her #SayPantsToTheTax campaign with M&S for the VAT to be removed on period pants.
